LOCATION: Walker Park on Ruddiman Avenue between City Hall and Library in North Muskegon

**SPACES :** The space fee is \$50 per lot for all original crafters, homemade items and fine art. Retailers or resellers space fee is \$75 per space. If confirmation is desired, please send a self-addressed stamped envelope or include your email address. Exhibit areas average 12' frontage. Stakes are not to be driven more than 6" into the ground. Vendors will receive a space number upon arrival. Your information packet with your space number can be picked up at the Community Center located beside the Library. *Set up time will be from 6:00 a.m. to 9:30 a.m..* Spaces may be shared but they may not be sublet or transferred. Unfortunately, all participants cannot be placed in the shade so please come prepared for the sun. There is neither a rain site available nor a rain date No applications will be accepted without full remittance in advance and there are no refunds. Any late registrations after August 1st will include a **\$25 late charge registration.**

**PARKING:** The parking lot along side the Community Center will be designated as handicap parking only. We request no parking on Ruddiman after 9:30 a.m. Please park your vehicle at the parking located at the high school's football field on Eimer. We will give you a red exhibitor tag to display on your vehicle so that you will not be towed as you are unloading.

**OTHER:** Good food is available starting with the Lions Club Pancake Breakfast, 8:00 a.m. – 11:00 a.m. and the Ice Cream Social located in the middle of the park that has a variety of food beginning at 10:00 a.m.. You will be given a nametag with registration, which will get you *free coffee* at breakfast and cuts in line. There are restroom facilities located in the handicap parking area and inside the Community Center.
